### **REMINDERS** UNLESS SURRENDERED, SUSPENDED OR REVOKED LICENSE SHALL BE RENEWED. MAY RENEW THREE (3) MONTHS PRIOR TO EXPIRATION. A SURCHARGE OF 50% OF THE REQUIRED ANNUAL FEE, CUMULATIVELY BY YEAR NOT PAID SHALL BE IMPOSED ON TOP OF THE CURRENT ANNUAL FEE.

- NOTIFY PDEA IN WRITING AT LEAST 60 DAYS IN ADVANCE FOR AN INTENTION TO DISCONTINUE/RETIRE THE P- LICENSE AUTHORITY GRANTED.
- A PRE- RETIREMENT COMPLIANCE INSPECTION SHALL BE CONDUCTED.
- WRITTEN NOTIFICATION ON LOSS OF LICENSE WITHIN 48 HOURS FROM OCCURRENCE TO PDEA COMPLIANCE SERVICE/REGIONAL COMPLIANCE SECTION, ADDITIONALLY SUBMIT NOTARIZED AFFIDAVIT OF LOSS AND POLICE BLOTTER.
- A SEPARATE PERMIT APPROVAL IS NECESSARY PRIOR TO IMPORT/EXPORT of CPECs, UNLESS SPECIFICALLY EXEMPTED
